**NOTICE**

This is regarding conduct of elections to elect five persons from among themselves by the heads of architectural institutions in India imparting full time instructions for recognized qualification as members of the Council of Architecture for a period of three years under clause (c) of sub-section of Section 3 of the Architects Act, 1972.

2. A copy of notification issued on 13<sup>th</sup> October, 2022 giving the date, the time and place for receipt of nomination papers, dispatch of voting papers etc. as required under Rule 8 of the Council of Architecture Rules, 1973 is **enclosed** for information and necessary action.

3. The term "Institution" has been defined in Regulations 2(e) of the Council of Architecture (Minimum Standards of Architectural Education) Regulations, 2020 to mean "the colleges / departments / schools of architecture in India imparting full time instruction for recognized qualifications". As such in case of composite institutions like NIT, IIT and University, the heads of architectural department have been included in the electoral rolls.

4. Heads of Architectural Institutions in India who wish to contest the election to be a member of the Council of Architecture may submit his / her nomination paper (Form-I). Nomination paper is also **attached**. The last date for receipt of nomination paper by the undersigned is **28<sup>th</sup> October, 2022, upto 04:00 PM.**
