Sir,

I have to state that the Executive Committee of the Council at its 183rd meeting held on February 19, 2018, perused a representation received from students (copy enclosed) undergoing 5-year B.Arch. degree course at Shree Banke Bihari Institute of Architecture, Meerut (UP14) complaining against the institution for serious deficiency in faculty and infrastructural facilities in the conduct of B.Arch. course. Further, no academic work is reported to be going on at the institution. Despite complaints from the students, no action is being taken by the institution. Due to this, the future and career of the students is in dark.

It may be further mentioned that the institution had also applied for closure of institution and the Council had sent you an email dated 22.02.2018 asking your institution to submit required documents along with charges, in order to consider your request for closure of institution. The requisite charges towards application and processing for closure are yet to be received by the Council from your institution.

The Executive Committee noted that the present intake of the institution in B.Arch. course has been put to zero by the Council due to lack of academic and physical infrastructure facilities in the institution as it had been imparting deficient education for B.Arch. Course in violation of Minimum Standards prescribed by the Council. The Committee after detailed deliberations in the matter decided that an explanation be sought from the Institution about the complaints received and the matter be also brought to the notice of the State Government and the concerned affiliating university.

The Executive Committee further decided that the Chairman and HOD/ Director of the institution be asked to appear before the Committee at its next meeting along with required documents and prescribed charges for closure, in order to redress the grievances of the B.Arch. students.

Accordingly, the institution is directed as under:

- i. To tender its explanation regarding issues raised by the students in their representation within 10 days of receipt of this letter;
- ii. The Chairman and HOD/ Director of the institution are required to appear before the Executive Committee to apprise on state of affairs of the Institution.

The date and time of the meeting shall be communicated to you in due course. If no reply is received from the institution within 10 days of receipt of this letter, the Council shall take appropriate decision in the matter.
