The Chairman informed the Members that the Executive Committee in its last meeting(s) issued show cause notices to the institutions for reduction of their intake due to non-maintenance of Minimum Standards of Architectural Education as prescribed by the Council and the Institutions were afforded an opportunity either to submit documentary evidence in their support or to seek opportunity of personal hearing by making payment of required fees.

ITEM NO.6 TO RATIFY THE DECISION TAKEN BY THE CHAIRMAN EXECUTIVE COMMITTEE ON THE ASSESSMENT REPORTS SUBMITTED BY THE INSPECTION COMMITTEES APPOINTED BY THE COUNCIL AND REVIEW APPLICATIONS/REPLY TO SHOW CAUSE NOTICES SUBMITTED BY INSTITUTIONS FOR GRANT OF APPROVAL FOR IMPARTING B.ARCH/M.ARCH. DEGREE COURSES IN THE COUNTRY.

The Chairman informed the Members that as authorized by the Executive Committee, he considered the Assessment Reports of Scrutiny Committee of the Council and also had considered the review application/replies filed by the institutions against the show cause notices issued by the Council and after considering the information/documents, decided the intake or otherwise in respect of the concerned institutions.

The Executive Committee perused the list of institutions along with decision of the Chairman as attached at Appendix-E of the Agenda along with replies/documents and forms/reports of the institutions and approved the decisions taken by the Chairman, Executive Committee.

ITEM NO. 7 TO CONSIDER THE ORDER DATED 04.06.2019, PASSED BY TE HON'BLE MADRAS HIGH COURT IN W.P.NO. 34676 OF 2018 FILED BY T.A.S.A. AGAINST THE COUNCIL OF ARCHITECTURE & ORS.

The Chairman informed the Members that the Academic Society of Architects (TASA), Chennai has filed a Writ Petition No.34676 of 2018 filed against the Council of Architecture before the Hon'ble Madras High Court challenging the decision of Council to implement the Council of Architecture Minimum Standards of Architectural Education, 2017.

The Division Bench of the Hon'ble Madras High Court has held that the Council cannot implement the 2017 Regulations unless they are approved and notified in the Gazette.

The Chairman informed that the Council will be filing a Special Leave Petition against the order of Division Bench as there are several judgments which have already upheld the minimum standards prescribed by the Council of Architecture pursuant to Section 21 of the Architects Act, 1972. Under Section 21 the Council is not required to make regulations and even the norms/guidelines framed by the Council of Architecture have statutory force.

The Executive Committee concurred with the Chairman and accordingly decided that the Council may get the matter legally examined and file an SLP before the Supreme Court of India against the Order of the Madras High Court.

ITEM NO.8 TO CONSIDER THE LETTER NO.4-26/2018-TS.VI DATED 31ST MAY, 2019 RECEIVED FROM THE MINISTRY OF H.R.D. REGARDING CONVENING OF EXECUTIVE COMMITTEE MEETINGS BY THE COUNCIL.

The Executive Committee perused the letter No. 4-26/2018-TS.VI dated 31.05.2019 received MHRD, Govt. of India, regarding letter dated 23.05.2019 written by Ar. Solomon Vedamuthu, Chennai, on the conduct of 202nd Meeting of the Executive Committee.

The Registrar-Secretary informed the Members that the Council has already replied to the MHRD in the matter stating that the Council is a perpetual body and conduct of elections for the office bearers of the Council is not a bar for carrying the urgent statutory functions of the Council of Architecture.

ITEM NO.9 TO CONSIDER THE PROPOSAL RECEIVED FROM AR.RAJENDRA KUMAR FOR "SYMPOSIUM ON INDIAN ARCHITECTURE" AT NEW YORK, USA.

The Chairman informed the Members that Ar. Rajendra Kumar, New Delhi, has submitted a proposal to Council regarding organizing a visit of Indian Architects to New York, Boston, USA, for promoting Indian Architecture and also holding a symposium on Indian Architects in New York, USA.

The Executive Committee perused the proposal and decided that the Council may associate itself with the conduct of symposium without any financial commitment. The Registrar-Secretary will make relevant communications to the concerned authorities on behalf of Council for facilitating visit of Indian Architects to New York, USA.

ITEM NO.10 ANY OTHER ITEM WITH THE PERMISSION OF THE CHAIR.

- i) **TO CONSIDER THE LETTER NO.34/18/2004-TPD(Services) DATED 11.06.2019 RECEIVED FROM MINISTRY OF COMMERCE AND INDUSTRY, GOVERNMENT OF INDIA, REGARDING PROSPECTS OF INDIAN ARCHITECTS IN CHINA.**

The Chairman informed the Members that he is in receipt of a letter 11.06.2019 dated on the Ministry of Commerce and Industry, Government of India addressed to the various stake holders requesting them to identify the issues and area of their interest for export of services to China.

The Members perused the letter dated 11.06.2019 and decided that the communication be sent to the Ministry of Commerce and Industry, Government of India, informing that the Council of Architecture is willing to have MRAs with the Authorities dealing with Architects in China for architectural services as there is good scope for Indian Architects to provide architectural services.

ii) **PROVIDING DATA OF STUDENTS PASSED IN NATA-2019 EXAMINATION TO ARCHITECTURAL INSTITUTIONS.**

The Chairman informed the Members that he after consulting the Executive Committee Members over telephone, decided to provide the data of qualified students in the NATA 2019 examination to the Institutions, on payment of Rs.25,000/-.

This will help the institutions to contact students who could not get admission in any Architectural Institutions for admission in the B.Arch. course and it also help students to find out institutions for admission to B.Arch. course. The Council in past also provided such data to architectural institutions for their information and record.

iii) **REGISTRATION OF MS. JAYA SINGH WITH DHANBAD MUNICIPAL CORPORATION AS AN ARCHITECT BASED ON FALSE DOCUMENTS.**

The Chairman informed the Members that he has received a complaint from some Architects that Ms. Jaya Singh has got herself registered with the Dhanbad Municipal Corporation by submitting false documents. She has submitted a false certificate of registration of Council of Architecture and other documents of the University etc.

The Executive Committee decided that the Council should bring this matter to the notice of SSP, Dhanbad for investigation of this matter and register an FIR and also bring to the notice of the Dhanbad Municipal Corporation for cancelling the registration of Ms. Jaya Singh and take further action after fraudulent action and accordingly authorized the Registrar, Council of Architecture, to carry on further necessary action in the matter.

iv) **TO CONSIDER THE REQUEST RECEIVED FROM STUDENTS PASSED B.ARCH DEGREE COURSE FROM NIT RAIPUR BASED ON LATERAL ADMISSION (2ND YEAR) OF THE B.ARCH UNIVERSITY.**

The Chairman informed the Members that the Council is in receipt of a representation from several candidates who have passed B.Arch. course by taking lateral admission but could not appear in the as Bridge Course as recommended by the Council of Architecture to the institution.

The Executive Committee after detailed deliberations in the matter noted that such candidates were earlier granted registration as an Architect by the Council upon their successful completion of the Bridge course of the first year subjects.

Since some students did not appear with the Bridge course conducted by the NIT Raipur at that time, The Council may request the NIT Raipur, University to conduct another examination/ Bridge course within 60 days and accordingly inform the Council so that these candidates can undergo the Bridge Course/ Examination for considering their cases for registration as an architect.

v) **CONDUCT OF COUNCIL MEETING:**

The Chairman informed the Members that the Meeting of the Council is to be conducted as more than 6 months has elapsed since the last Council meeting held on 22.11.2018.

The Chairman also informed the Members that though the process for election of office bearers of the Council is underway, however, the same is not a bar for holding the meeting of the Council and carry on the urgent/statutory work required to be carried on by the Council under the provisions of the Architects Act, 1972 and rules and regulations framed thereunder. Accordingly, it was decided to hold the Council meeting on 27th July, 2019 at New Delhi.

The Meeting ended at 5:00 p.m with the vote of thanks to the Chair.
